HUNUTLU FACILITY EMERGENCY RESPONSE SERVICE CONTRACT WITHIN THE SCOPE OF THE LAW NO. 5312 ON THE PRINCIPLES OF EMERGENCY RESPONSE AND COMPENSATION OF DAMAGES IN CASE OF POLLUTION OF THE MARINE ENVIRONMENT WITH OIL AND OTHER HARMFUL SUBSTANCES

## THE ABOVE-MENTIONED SERVICE SHALL BE PUT OUT FOR PUBLIC TENDER LASTING FROM 10 NOV. 2023 UNTIL 15 DEC.2023.

## THE SCOPE OF SERVICE SHALL BE AS FOLLOWS.

The CONTRACTOR is obliged to provide the following services and for this purpose, the requirements of the Communiqué will be met and the conditions required for the effective performance of the work will be provided.

**1.** In order to protect sensitive areas and ensure environmental safety, as of the location of EMBA, the CONTRACTOR will provide pre-booming services under the conditions specified in ship operations. The equipment, material and so forth for the pre-booming services will be provided by the CONTRACTOR.

**2. Inspection:** The CONTRACTOR will make the necessary preparations in advance for the inspections will be made to the coastal facility regarding the status of other obligations and to be prepared for the implementation of the relevant legislation of the Ministry and the (Abolished) **Undersecretariat** (current Ministry of Transportation and Infrastructure), ensure that the Coastal Facility is fully prepared within the scope of the relevant legislation, and during the inspection It will be present with the Coastal Facility personnel or, if requested by the Coastal Facility, will participate in inspections on behalf of the Coastal Facility.

**3. Pollution Response, Pollution Control and Cleaning:** In case of pollution in the Coastal Facility due to both sea and land operations and other sources, the CONTRACTOR shall respond to the pollution with the appropriate response method according to the nature of the event within the framework of the systems and methods foreseen by the Coastal Facility Emergency Response Plan and the relevant legislation. CONTRACTOR will carry out the activities of cutting the source of pollution, control and clean the pollution. In such cases; The management, control and coordination of the activities of other elements participating in the response operations and relations with these elements will be fulfilled by the CONTRACTOR. In response operations, the Incident Scene Coordinator will be assigned by

the CONTRACTOR.In the above-mentioned response operations, if EMBA materials and equipment is lost due to external resorces pollution, the CONTRACTOR shall be responsible for Recourse and compensation to the responsible party on behalf of the EMBA after the end of the response operations.

The CONTRACTOR shall intervene immediately in cases of ex officio learning, and in other cases, within maximum one hour after notification, and shall be ready for duty for 24 hours without interruption for this purpose. In order to deliver the notices, a staff member will be assigned 24 hours a day at a place to be determined by the CONTRACTOR and approved by the BOTAŞ Port Authority. The notification procedures and principles will be notified to

## EMBA.

The CONTRACTOR will also provide consultancy services and provide guidance for the effective execution of coordination and other administrative duties to be performed by the Coastal Facility, apart from the execution of the response operations within the scope of the implementation of the emergency response plans in case of pollution.

**4. Cost and Compensation for Pollution Damages:** The CONTRACTOR shall prepare the request application forms on behalf of the Coastal Facility, collect the evidence and documents, will provide support in claiming compensation from those responsible for the pollution or the GUARANTOR by making a request.

**5. Personnel Training:** Training and certification of the personnels of the coastal facility who are required to receive training in accordance with the training obligations within the scope of "Procedures and Principles of Training Seminars and Practice Programs on Preparedness and Response to Pollution Caused by Oil and Other Harmful Substances (Circular 2010/4)" will be provided. The initial trainings required by the personnel will be arranged in return for a fee, and the renewal trainings will be carried out once a year within the scope of this contract. These trainings will be requested by EMBA after the signing of the contract, provided that it is notified 15 days in advance.

**6. Execution of Drill Obligations:** Programming and organization of two drills per year as the execution of the drill obligations of the coastal facility within the scope of "Procedures and Principles of Training Seminars and Practice Programs on Preparedness and Response to Pollution Caused by Petroleum and Other Harmful Substances (Circular 2010/4)", The reporting to the (former) Undersecretariat (current Ministry of Transport and Infrastructure) and the execution of the drills will be provided by the CONTRACTOR. No fee will be charged from EMBA for this service.
