<b>Reason of Inquiry:</b>	EMBA need the monitoring and supervision service for the construction of a transmission lines and substation project for a solar power plant. The transmission lines shall be two separate lines (154 kV, 1272 MCM, 5+5 km) between the solar power plant and 154kV Bozkurt – Tefenni Transmission Line (T-connection). The substation shall be a 154/36 kV 70 MVA substation.
<b>Scope of service</b>	
1. Providing the necessary construction supervision for the construction of the transmission line. Making necessary weekly and monthly reports regarding the construction of the transmission line and controlling the general progress of the process.	
2. Providing necessary construction, electrical and mechanical construction supervision for the construction of the substation. Making necessary weekly and monthly reports regarding the construction of the substation and controlling the general progress of the process.	
3. Consultancy (information collection from TEIAS about reactive power compensation, secondary system issues, etc.)	
<b>Requirements of the quotation:</b>	
1. Qualification of the service provider shall be submitted.	
2. The name of the major customers in the past two years of the service provider shall be provided.	
3. The quotation should not include the value-added tax and stamp tax related to the agreement.	
4. The price shall cover all the expenses that may incur during the service.	
5. The quotation and service language shall be in Turkish and/or English. In case of any contradiction, English version shall prevail.
